

CUB KART DISCLAIMER

SAFETY RULES FOR CUB KARTS



This form must be read carefully and completed before any child partakes in any activities.
PARENTS MUST READ AND SIGN THIS DISCLAIMER, IT'S A LEGAL DOCUMENT

I give my **consent** to allow my child/children to participate in a Cub Kart Party and

I CONFIRM AND UNDERSTAND THAT:

1. This activity carries risks if not followed in accordance with the stated rules, which will be fully explained to all children.
2. The potential of injury does exist, the karts could cause injury if drivers collide.
3. Children are to look where they are driving their Kart observing a minimum distance of 1.5 meters between the kart in front.
4. Drivers must keep both hands on the steering wheel, no hands outside of cockpit area.
5. Long hair must be safely tied back, no loose clothing or jewellery permitted.
6. Cub Karts are to remain within the designated track area as defined by the outer cone perimeter.
7. Spectators are not to enter the track area, they must remain in the spectating area.
8. Drivers are not allowed to leave the cockpit of their Karts until instructed by staff as karts must be switched off first.
9. Any child/children driving the Cub Karts in a reckless manner or disobeying safety rules shall forfeit their go.
10. My child is over the age of 3+ years and I give my consent for them to partake in this activity knowing the risks involved.
11. My child/children have no medical conditions that would prevent them from participating in driving cub karts which Dorset Adventure Sports provide (please make staff aware of any medical conditions during briefing and state below).

RELEASE AND RENTAL AGREEMENT:

Although all steps are taken to ensure your child's/children's safety, Dorset Adventure Sports shall not be liable for injury or damage caused through the actions of others. All property left on the premises or in the car park is at the owners risk. Dorset Adventure Sports shall not accept any responsibility for loss or damage to such items.

I the undersigned parent, understand and agree to let my child participate in this activity, and recognise that there are such risks as stated above. I agree to cover the cost of any damage caused due to my child/children not following the rules.

I have read and fully understand all the terms of this document and confirm that I am not relying on any statements or representations by any person or entity as an inducement to me fully and voluntarily engaging in the stated activities assuming the risks and obligations stated above by signing this document. I hereby waive whatsoever without limitation that I might have against Dorset Adventure Sports, the owners of the property on which the events are being held and any other player who might injure me howsoever arising, and I make this release on behalf of myself, my heirs, executors and administrators.
